

# RESOLUTION 2016 - 02

## **Amended High Priority Corridors**

**WHEREAS**, Section 72-5-402 of the Utah Code, the Legislature finds and declares that the planning and preservation of transportation corridors is a public purpose; and

**WHEREAS**, Section 72-403 of the Utah Code directs the Utah Transportation Commission to designate transportation corridors as high priority transportation corridors for corridor preservation purposes; and

**WHEREAS**, the Transportation Commission adopted a High Priority Corridor Preservation List on April 2010; and

**WHEREAS**, additional high priority corridors will be added and deleted by this resolution;

**NOW THEREFORE**, be it resolved that the list of high priority corridors be amended to add SR-73 (Corey Wride Memorial Highway);


